

## **Scantron Analytics License Agreement**

- 1. Customer acknowledges that Scantron Analytics contains or incorporates proprietary software (the "Qlik Products") owned by Qlik Technologies Inc. and its affiliates (collectively, "Qlik"). Scantron Corporation ("Scantron") grants the Customer a non-exclusive, non-transferable, revocable, and non-assignable license to use the Qlik Product only in accordance with the terms of this Scantron Analytics License Agreement ("License Agreement").
- 2. Customer is expressly prohibited from using the Qlik Products in any way other than integrated within Scantron Analytics. Except as integrated within Scantron Analytics, Customer has no independent license or any other independent right to the Qlik Products as a stand-alone solution, and is expressly prohibited from using the Qlik Products in any way other than as such Qlik Products are integrated within Scantron Analytics. Qlik is a third party beneficiary of this License Agreement and may enforce the applicable terms and conditions of this License Agreement against Customer.
- 3. Customer may only use the Qlik Products for its own internal purposes in accordance with the terms of this License Agreement. Customer shall not, directly or indirectly: (i) sell, rent, sublicense, publish, display, loan, distribute or lease the Qlik Products; (ii) transfer to any other person or entity any of its rights to use the Qlik Products except as expressly permitted hereunder; (iii) reverse engineer, decompile, disassemble, modify, translate, make any attempt to discover the source code of the Qlik Products or underlying ideas or algorithms of the Qlik Products or any software contained therein, or create derivative works from the Qlik Products unless explicitly permitted by applicable and mandatory law; (iii) remove, delete or modify any copyright notices or any other proprietary notices or legends on, in or from the Qlik Products; or (iv) use the Qlik Products in any manner not authorized by this License Agreement.
- 4. Qlik, or its respective suppliers or licensors where applicable, owns and retains all right, title, and interest in and to the Qlik Products, and its respective patents, trademarks (registered or unregistered), trade names, service marks, logos, designs, copyrights, trade secrets, and confidential information. Except to the extent specifically provided or conveyed under this License Agreement, Customer does not acquire any right, title, or interest in or to the Qlik Products or any intellectual property rights contained therein.
- 5. Customer agrees to: (i) comply with all applicable local, state, national, and foreign laws and regulations in connection with Customer's use of the Qlik Products, including those related to data privacy, copyright, export control, and the transmission of technical or personal data; and (ii) use reasonable security precautions for providing access to the Qlik Products by its employees or other individuals to whom Customer provides access and to prevent unauthorized access to use of the Qlik Products. Customer is fully responsible for all data it introduces into the Qlik Products, including but not limited to adequate protection and backup, and none of Scantron, Qlik, or their respective affiliates shall have any obligation or liability with respect thereto.
- 6. Individual third-party software components (the "Third-Party Software"), each of which has its own copyright and its own applicable license conditions, may be distributed, embedded, or bundled with the Qlik Products. Such Third-Party Software is separately licensed by its copyright holder. Use of the Third-Party Software must be in accordance with its license terms available at http://www.qlik.com/us/legal/license-terms. No representations, warranties, or other commitments of any kind are made regarding such Third-Party Software.
- 7. If Scantron becomes aware that Customer is in breach of one or more terms of this License Agreement, then Scantron will promptly provide written notice of the alleged breach to Customer. Within thirty (30) days following the date of Customer's receipt of such written notice from Scantron, Customer shall either (A) cure the alleged breach, or (B) provide verifiable evidence of Customer's compliance with the relevant terms of this License Agreement with respect to which Scantron has alleged that Customer is in breach. In the event that Customer fails to perform either (A) or (B) above in a timely manner, then this License Agreement, along with Customer's rights to access/use the Qlik Products, may be terminated by Scantron upon the provision of written notice of termination to Customer.
- 8. Customer shall ensure that (i) any copy of the Qlik Product is produced only in accordance with the terms of this License Agreement and for the Customer's own benefit, (ii) any such copy is clearly marked subject to copyright and confidentiality restrictions, and (iii) a written list is maintained of the number of copies and place of storage. Customer shall discontinue use immediately, and shall promptly destroy or return all copies of the Qlik Products within a reasonable period of time following the termination of this License Agreement. Further, Scantron shall reserve the right to conduct audits at Customer's premises to ascertain whether Customer's use of the Qlik Products complies with the provisions of this License Agreement.
